1. December 20, 2021. Ben Zeller, County Judge, called to order the Commissioners Court Special Term for Monday, December 20, 2021 at 10:00 a.m.

2. Invocation and Pledges.

2. December 20, 2021. Judge Ben Zeller opened the meeting with prayer and the reciting of the Pledges of Allegiance of the United States of America and the State of Texas.

3. Citizens Communication.

3. December 20, 2021. Judge Ben Zeller opened the meeting to anyone wishing to address general County business which was not on the meeting agenda.

Michael Vonderau of 2204 E. North Street, Victoria, Texas, thanked the District Attorney's Office for prosecuting an animal abuse case and thanked Commissioner Garcia for his involvement and wished the Court a Merry Christmas.

James Collins of 284 Haynes Road, Victoria, Texas, spoke to the Court about hunting and dog issues around his property.

Nicole Nguyen, Regional Director, and Cynthia Ramirez, Community Liaison, for Belong were present. Mrs. Ramirez handed Belong information to the Court. Ms. Nguyen introduced herself and Mrs. Ramirez and also explained the Belong program and services. She also stated they would like to come back in the near future and provide a full presentation to the Court.

Bill Pozzi, Republican Chair, announced the ballot draw for today has been rescheduled to Thursday, December 23, 2021 at 9:00 a.m. and wished everyone Merry Christmas.

Tax Code, Chapter 312, County Judge Zeller opened the public hearing for the designation of a reinvestment zone at the Port of Victoria South Industrial Park. Jonas Titus, Executive Director with Victoria Economic Development Corporation, gave a recap and process of the designation of a south tract reinvestment zone at the Port of Victoria Industrial Park. Mr. Titus stated a reinvestment zone is a finding in the area that would attract major investment in the zone, which would benefit the property included in the zone, and contribute to the economic development in the county. County Judge Zeller stated this would last for five years and would enable the Court or other taxing entities to be able to offer incentives, if the need arose.
